# THE CORPORATION OF THE DISTRICT OF KENT

## BYLAW NO. 1699

*"A bylaw for the Levying of Taxation Rates for Municipal, Policing, Hospital, Regional District, Dyking and Drainage Purposes for the year 2022"*

---

THE COUNCIL of The Corporation of the District of Kent, in open meeting assembled, ENACTS AS FOLLOWS:

1. The following rates are hereby imposed and levied for the year 2022:
  - A.
    - (i) For all lawful General Municipal purposes of the municipality on the value of land and improvements taxable for general municipal purposes, rates appearing in column "A" of the Schedule attached hereto and forming a part hereof.
    - (ii) For Policing purposes on the value of land and improvements taxable for general municipal purposes, rates appearing in column "B" of the Schedule attached hereto and forming a part hereof.
    - (iii) For purposes of the Agassiz-Harrison Mills Diking Area on the value of land and improvements, as said lands are described and defined pursuant to the "Municipalities Enabling and Validating Act", taxable for general municipal purposes, rates appearing in column "C" of the Schedule attached hereto and forming a part hereof.
    - (iv) For hospital purposes on the value of land and improvements taxable for Regional Hospital District purposes, rates appearing in column "D" of the Schedule attached hereto and forming a part hereof.
    - (v) For purposes of the Fraser Valley Regional District on the value of land and improvements taxable for general municipal purposes, rates appearing in column "E" of the Schedule attached hereto and forming a part hereof.
  - B. For purposes of the Agassiz Drainage Area a special rate of FOURTEEN DOLLARS AND TWENTY-NINE CENTS (\$14.29) per acre upon all real property as described and defined pursuant to the "Municipalities Enabling and Validating Act" for said Drainage Area, PROVIDED that the special rate so levied shall be not less than FIFTY-SEVEN DOLLARS AND SIXTEEN CENTS (\$57.16) on any parcel of land in said Drainage Area.

- C. For the purposes of the Harrison Mills Drainage Area a special rate of SEVEN DOLLARS AND TWENTY-EIGHT CENTS (\$7.28) per acre upon all real property as described and defined pursuant to the *Municipalities Enabling and Validating Act* for said Drainage Area, PROVIDED that the special rate so levied shall be not less than TWENTY-NINE DOLLARS AND TWELVE CENTS (\$29.12) on any parcel of land in said Drainage Area.
- 2. The Collector shall, pursuant to Bylaw No. 1052, cited as the "Percentage Additions to Current Taxes Bylaw, 1994" add the percentage addition to all current taxes or rates remaining unpaid at the time and dates stated in said Bylaw No. 1052.
- 3. The minimum amount of taxation upon a parcel of real property shall be ONE (\$1.00) DOLLAR.
- 4. This bylaw shall be cited for all purposes as the "Annual Tax Rates Bylaw No. 1699, 2022".

READ A SECOND TIME this 25<sup>th</sup> day of April, 2022.

READ A THIRD TIME this 25<sup>th</sup> day of April, 2022.
