# THE CORPORATION OF THE DISTRICT OF KENT

## BYLAW NO. 1757

*“A bylaw to exempt certain non-profit organizations from taxation for the year 2026”*

---

WHEREAS the *Community Charter* provides that Council may, by bylaw, exempt from taxation, land, or improvements that are owned or held by a charitable, philanthropic or other non-profit organization, and that Council considers are used for a purpose that is directly related to the purposes of the organization;

NOW THEREFORE the Council of The Corporation of the District of Kent in open meeting assembled enacts as follows:

### 1. EXEMPTION FROM TAXATION

The following described properties are exempt from land and improvements taxation under the authority of Section 224(2)(a) of the *Community Charter* for the year 2026:

2. BYLAW COMES INTO FORCE

This Bylaw shall come into force on January 1, 2026 and ends on December 31, 2026.

3. ADMINISTRATIVE PROVISIONS

- a) "2025 Non-Profit Organizations Permissive Tax Exemption Bylaw No. 1740, 2024" and any amendments thereto are all hereby repealed.
- b) If any section, subsection, sentence, clause or phrase of this bylaw is, for any reason, held invalid by the decision of any court or competent jurisdiction, the invalid portion shall be severed and the decision that is invalid shall not affect the validity of the remainder of this bylaw.

4. TITLE

This Bylaw may be cited as "2026 Non-Profit Organizations Permissive Tax Exemption Bylaw No. 1757, 2025".

READ A FIRST TIME this 15<sup>th</sup> day of October, 2025.

READ A SECOND TIME this 15<sup>th</sup> day of October, 2025.

READ A THIRD TIME this 15<sup>th</sup> day of October, 2025.
